Dry Cargo

In the Capesize segment, clients of Santoku Shipping sold their MV 'IMPERATOR AUSTRALIS' (ABT 176,387 DWT, BLT 12 SHANGHAI WAIGAOQIAO, BWTS) at region USD 25.5m to Greek Buyers.

Meanwhile, Japanese Owners sold their scrubber-fitted Kamsarmax MV 'AOM SOPHIE II' (ABT 81,816 DWT, BLT 20 SANOYAS, BWTS + SCRUBBER FITTED) at region USD 31.5m to Greeks

Elsewhere, clients of Selmer Bulk sold their Supramax bulkcarrier MV 'INGWAR SELMER' (ABT 58,018 DWT, BLT 11 SINOPACIFIC DAYANG, C:4 x 30T, BWTS) for USD 11.65m to Chinese Buyers.

Lastly, in the Handysize segment, clients of Nova Marine Carriers sold their MV 'SIDER OLYMPIA' (ABT 38,182 DWT, BLT 13 IMABARI, BWTS, C:4 x 30.5T) at region USD 15.75m, while clients of ID Shipping sold their MV 'ID PIONEER' (ABT 35,534 DWT, BLT 12 TAIZHOU MAPLE LEAF, C:4 x 30.5T, BWTS) at region USD 10m to undisclosed Buyers.
